- ✓ **Discount for two children** 10% off both children's fees. (This discount does not apply where we are accommodating shifts, if any other discount/Early Education funding is being applied. All discounts are void if fees are in arrears).
- ✓ Early Start/late finish: The above prices are based on your permanently booked sessions. For ad hoc changes eg 7.30 instead of 8.00 or 8.00 instead of 8.30 a charge of £8.50 applies subject to availability.
- ✓ Extra Hour: £9.00 (this also applies when an ad hoc change is requested eg 8 instead of 8.30 am would be £8.50) Lunch £5.00 Tea £4.00 (if extra hour or non-fully paid session is taken at meal time)
- ✓ Late Charges times must be strictly adhered to £10 per 15 minutes or part of for arrivals after 6pm. To clarify the drop time is the earliest you can arrive at the nursery and the collection time is the time your child leaves the room. Please ensure that you choose the appropriate time.
- ✓ **Early years funding:** Think2 Funding fee's £1.50 per ½ day and £3.00 per full day. 3 and 4-year-olds in England are entitled to Early Year grant Funding please ask in the office for more information.
- ✓ **Shift workers** The nursery can accommodate shift patterns there is an additional charge of £1.75 per session.
- ✓ **Annual Holidays** Full time children of six months duration or greater(10 sessons a week with no more than 15hours funded or 30hrs stretched) are entitled to two weeks holiday per academic year at no charge anytime during the year. All other children are entitled two weeks holiday (pro rata) will be charged at 60% of normal fees if taken in the 6 weeks Summer Holiday and advised to us in writing/e-mail with 4 weeks or greater notice.
- ✓ **Bank Holidays** are charged. Where a bank holiday falls on a Monday, if desired we will allocate an alternative day in lieu in the following month (subject to availability and terms). Requests must be made in the month of the bank holiday, after which time we will not be able to allocate a day in lieu. No cash alternative is available or will be offered. Days in lieu are not given where discounts have been or are being applied, where we are accommodating shifts or if accounts are not fully settled by the due date.
